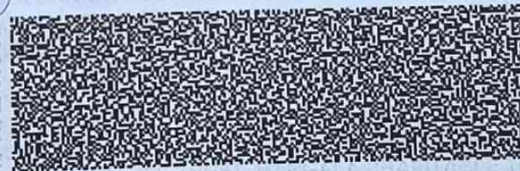

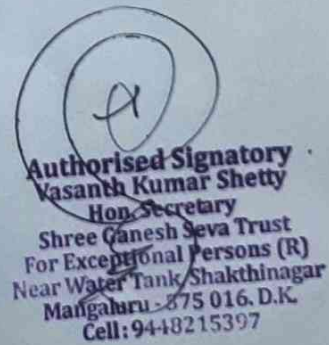
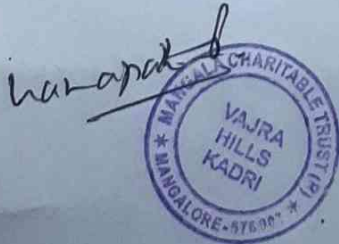
WHEREAS both the parties have agreed to enter into a Memorandum of Understanding consisting of following mentioned terms and conditions, which were agreed upon by both parties.

WHEREAS the First Party to this Memorandum of Understanding [hereinafter referred to as "MOU"] runs several renowned Institutions such as Mangala College and School of Nursing, Paramedical, Physiotherapy & Allied Health Science colleges in its campus at Neermarga.

The First Party proposes to commence course for Speech and Hearing in its Campus and has in this regard obtained necessary approvals from Rajiv Gandhi University and Health Sciences and Government of Karnataka. It has also applied for approval from Rehabilitation Council of India [RCI]. The students successfully completing the said course will be able to train and teach the Intellectually Disabled and the persons those who are suffering with Speech problems.

The above course of Speech and Hearing involves internship wherein the students are required to interact with Intellectually Disabled as part of the syllabus and clinical postings. This would enhance the capabilities of such students with problems of Speech and Hearing which would benefit the society in general.


WHEREAS, the Second Party is a registered Trust and it owns and runs Saanidhya Residential School & Training Centre for Mentally Challenged at its Campus located in Shakthinagar, Mangalore. It has vast experience in training Intellectually




Disabled and hence the First party wishes to avail its rich experience in training the students of First Party.

AND WHEREAS both the parties with an intention to train the Students of First Party, this Memorandum of Understanding is entered into and it WITNESSETH AS UNDER:

1. Second Party agrees to permit the 'Interns' of First Party to interact and engage with the children studying/housed at Second Party. And the First Party also agrees to post the Interns to Saanidhya Skill Training Centre for Endosulfan Victim, Ujire, Belthangady Taluk another Centre of Second Party.
2. The First Party Interns during the postings at Second Party shall be required to be present in the second Party campus.
3. The Interns of First Party during the postings shall attempt to improve the communication skills of children of Second Party.
4. First Party may provide financial support to the Second Party by way of Contributions in the form of Donations etc in their social cause to improve the life skills of their Children.
5. First Party agrees to provide health screening camps including health check-ups of the students of Second Party in its campus.
6. The First Party shall provide free of costs 'Lesson plans' and 'post therapy evaluations' for needy Intellectually Disabled of Second Party.
7. The First Party shall provide free of costs post therapy counselling and awareness programs to the parents/caretaker of needy Intellectually disabled children of Second Party.
8. Second party agrees to share the PWD Certificate and Government Orders related & other required necessary documents required by RCI.
9. The terms of this MOU shall be in force for a period of three[3] years commencing from the date of this MOU. Both parties are at liberty to renew the MOU for any such period agreed upon mutually.
