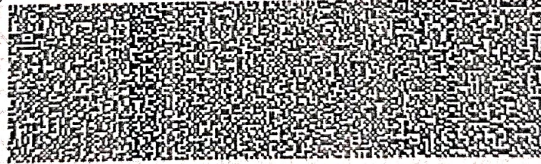
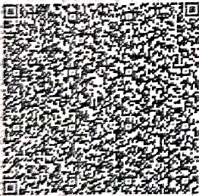

WHEREAS

The First Party runs several renowned institutions including Mangala College and School of Nursing, Paramedical, Physiotherapy, Allied Health Sciences, and Speech & Hearing programs at its campus in Neermarga, Mangaluru.

The First Party conducts academic and clinical training programs in Speech and Hearing, Physiotherapy, and Allied Health Sciences affiliated to Rajiv Gandhi University of Health Sciences (RGUHS) and recognized by the Government of Karnataka. The institution also complies with the guidelines of the Rehabilitation Council of India (RCI) wherever applicable.

The Second Party, St Agnes Special School, Bendoor, Mangaluru, is an institution dedicated to the education, rehabilitation, and overall development of children with special needs, including children with intellectual disabilities, developmental delays, and communication disorders.

Both parties recognize the importance of early intervention, therapy services, and clinical exposure for students, as well as the rehabilitation and holistic development of children with special needs.

Therefore, both parties have mutually agreed to collaborate through this Memorandum of Understanding under the following terms and conditions.

#### TERMS OF COLLABORATION

1. The Second Party agrees to permit students and interns from the First Party's institutions (Speech & Hearing, Physiotherapy, and Allied Health Sciences) to interact with and observe children with special needs at St Agnes Special School as part of their clinical postings, internships, and training programs.

2. The First Party shall provide professional services to the children of the Second Party, including:

Speech and Hearing assessment and therapy services

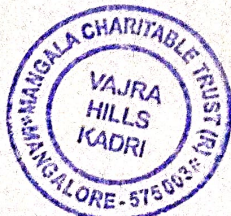
Occupational Therapy services

Physiotherapy services

Other rehabilitation and allied health interventions as deemed appropriate.

3. These services may be provided at the campus of the Second Party or at the First Party's campus, based on mutual convenience and prior scheduling.

4. The collaboration will also facilitate clinical training for students, enabling them to gain practical experience in assessment, therapy planning, and rehabilitation of children with special needs.

5. The First Party may organize health screening camps, therapy camps, and awareness programs for the children of the Second Party and their parents/caregivers.

6. The First Party shall provide guidance, counselling, therapy plans, and post-therapy evaluation reports for the children attending the therapy sessions.

7. The Second Party shall extend cooperation to the interns and faculty of the First Party in conducting therapy sessions, assessments, and rehabilitation activities.

8. The Second Party may share necessary documentation related to the children, including disability certificates and relevant records, if required for academic, clinical, or regulatory purposes while ensuring confidentiality.

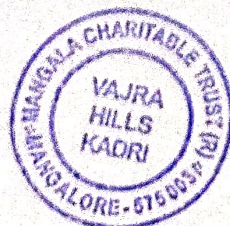
9. Both parties may jointly organize awareness programs, workshops, parent training sessions, and community outreach activities related to disability management and rehabilitation.

The MOU may be renewed by mutual consent.


Either party may terminate the agreement by giving three months' written notice to the other party.

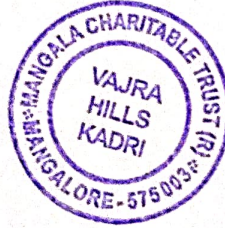
